# Half Yearly Industry Performance and Key recommendations

Mr. Vinnie Mehta Interview with Autocar Professional for Half Yearly Industry Performance and key recommendations

## Can you elaborate the underlying raw material challenges that could break the speed of industry's recovery?

There is a challenge in terms of the raw material prices going up steadily. The prices of steel, which forms 70 percent of a vehicle's construction, have risen between 5 and 7 percent in Q2 of FY2021 as have prices for non-ferrous materials, notwithstanding the fact that compared to last year, the rupee has fallen significantly too. Moreover, we are also seeing the cost of iron ore and cooking coal simultaneously rising, and with these being the input materials for the manufacturing of steel, there is a direct correlation in the price rise. While on one end, the cost is going up, with the economic recovery in India being steeper compared to other parts of the world, demand is also growing higher. And as a result, there could also be constraints regarding raw material availability in the near future.

## ACMA has stressed incentives for localisation of auto electronics in its recommendations to the government. What is the objective?

While on the taxation front, there isn't anything substantial that the industry can be demanding of, so what is important for us is to see how we can grow manufacturing in India and enhance localisation. If auto electronics is going to comprise about 20-25 percent of the cost of a vehicle in the future, we need to de-risk from a foreign exchange perspective as well. Since we do not have a sizeable presence in this area, our expectation is that the PLI scheme should bring the right way forward for the localisation and manufacturing of auto electronics in the country. Therefore, we would request the Ministry of Electronics and Information Technology (MEIT) to include auto electronics manufacturing in the scheme for promotion of manufacturing of electronic components and semiconductors (SPECS) or introduce a standalone PLI scheme to push auto electronics manufacturing in the country. A lot of the Indian component players have already struck JVs in the area of auto electronics and have positioned themselves to be able to move to the next level quickly. So, at this point if there is a policy that can act as an enabler, it would certainly enhance the pace.

## Do you think the demand will be sustained across vehicle segments as we move away from the festive season?

As a thumb rule, twowheeler sales account for 20 percent of the component industry's revenue, whereas PVs and CVs bring 40 and 20 percent, respectively. With the Q1 (FY2021) being specifically bad, it's a good thing that volumes in two-wheelers and passenger vehicles are reaching pre-Covid levels like what we saw during the festive season. Passenger vehicles are doing good as people want to be safe and even though the public transport is slowly getting back to normal, there continues to be a risk. CVs have also started to come up and interestingly, the rural market continues to do well in both PV and twowheeler segments.



## Is the industry impacted by the farmers' protest in North India? Do you think tractor sales are going to be slow as a result?

While none of the ACMA members have raised an alarm as yet, we are concerned that if the situation of the protest extends further, there could be some disruptions. Having said that, the supply chain does factor in a buffer of three to four weeks of inventory at any given point in time. Coming to tractor sales, it is a very cyclical business because tractors are predominantly required during the sowing season. And right now, being closer to the crop harvest, I don't think so there will be such a huge impact on tractor sales due to the ongoing protest.

#### CONFERENCE ON 'EV POWER ELECTRONICS SOLUTIONS'

ACMA, Sub-Pillar xEV & Future Mobility, organized a conference cum interaction opportunity on 'EV Power Electronics Solutions' and had invited major Power Electronics players on 14th and 15th December, 2020.

The objective of session was to; Understand the available EV solutions and use cases, enable to adopt faster and easier, To create an ECO system in India so that OEMs, TIER 1s & 2s can get aligned and benefit and Learn from the global solutions and make it suitable to our need through local innovations/adaption.

Mr. Nishant Arya, Chairman, xEV & Future Mobility sub-Pillar inaugurated the session with a welcome address and advised that customization is the key in Power Electronics.

Mr. Suresh D. Leading-PE in Sub Pillar xEV & Future Mobility lead this first-of-its-kind event on Power Electronics. While summing up- Mr. Suresh advised that we need to have a good knowledge in PE. You cannot bring the system as it is available elsewhere, it needs local development & localized solutions to bring affordability and acceptability.

During the course of interaction, impetus was given to the technologies like:

- 1. Wireless BMS and next gen battery management system tech
- 2. Mass weight, Motor Controller, BMS Chargers
- Solutions starts from system level verification, Battery Cooling Management control etc.
- 4. Motor controller, Mass Weight
- Various simulations were addressed

The participants also got opportunity to have virtual meetings with the PE Companies of their interest during the interaction. Some of the companies having technologies like Interface ICs, Motor controller ICs, DC-DC converter ICs, BLDC Motor Driver ICs, Battery Charger ICs, LDO, Controllers for DC-DC, H-bridge IC's, Buck-Boost Converters etc interacted with the participants.

A total of seven companies presented on available solutions like; Analog Device, Ansys, Infineon, Millenium Semiconductors, NXP, Renesas, while Texas Instruments presented on available solutions in Power Electronics.

More than 150 participants joined the event and the program was well received with excellent feedback.



#### WEBINAR ON VIRTUAL SUPPLY CHAIN & LOGISTICS CONFERENCE

ACMA, along with International Purchasing Offices (IPO) Forum of ACMA organized a webinar on Virtual Supply Chain & Logistics on 27th January, 2021. The conference was organized in view of the supply chain efficiencies & logistics costs that are impeding Indian companies' ability to gain a larger global market share.

Specifically due to the impact of COVID 19, which has changed global dynamics. Globally, the trend of China Plus One (China +1) strategy to de-risk the supply chain will have its direct impact on Indian companies. They are well positioned to take advantage of this global shift despite facing tough competition from SE Asian countries. Global OEM's recognizes the advantages of India and the resilience that the Industry has shown despite acute challenges during the pandemic, while sourcing components for their global organizations through their International Purchase Offices (IPO's).

#### Some of the key Highlights of the session was:

- There are significant growth opportunity, all the IPO's plan to double India sourcing in the next five years
- Labour costs in China has increased significantly in the last few
- India ranks high on quality but still has some way to match quality of European suppliers
- A right combination of automation and labour skilling will make India very competitive in future
- Showcasing India supplier capability to OEM's Engineering and R&D teams in addition to purchase teams
- Focus on core competence and outsource supply chain.
- Invest in technology to achieve competitiveness Al/ML, Digital, Drones, Robotics

The IPOs who participated in the conference were; John Deere, MAN Trucks and Buses, Valeo, Meritor, Volvo gave their perspective on the subject along with three PL companies TVS Supply Chain Solutions, GEFCO and DB Schenker.

The session witnessed participation by over 100 delegates and the conference was well received by the learned audience.

#### SPECIAL INTERACTIVE SESSION WITH MR. SUNIL DESHMUKH

ACMA, Western Region organized special interactive session with Mr. Sunil Deshmukh, Head- Regional Sourcing (IPO), Skoda Auto Volkswagen (I) Pvt. Ltd. on 8th December, 2020

Mr. Piyush Tamboli, Chairman, ACMA Western Region while welcoming the participants expressed that such interactions brings an opportunity to have 1st hand information about top global brand VW Group.

Addressing the participants Mr. Sunil Deshmukh, he informed audience that VW globally produces 44 thousand vehicles per day, it has under its umbrella 12 strong brands and are present in 150 markets with global sales at around 11 million per annum and global market share of around 12 per cent. While, touching upon oopportunities & challenges for Indian suppliers in VW group component export business, Mr. Deshmukh, said that the group is shifting from conventional vehicles to electric mobility. It is expected that the shift to EV would be around 30 percent by 2030. Engine & Foundry, Chassis & Battery Systems, Light Vehicle Solutions and E -Vehicle Components are the areas where suppliers are expected to contribute significantly, he further added.

Speaking on key drivers for exports business Mr. Deshmukh mentioned component export business is long term commitment, no gain from short term efforts. For global competition supplier need to stand top in all aspects. Flexibility in operations is key driver for profitable export business, he added.

He also shared a presentation having the information on the current state of industry and covered following points:

- 1. Presentation of VW group IPO (Regional Sourcing) & current activities in India
- Current market scenario on Group component export & impact of Covid 19
- 3. Opportunity for Indian suppliers in VW group component export business
- 4. Expectation from suppliers



## BUILDING INDEPENDENT AFTERMARKET OPEN CATALOGUE FOR ACMA MEMBERS

ACMA, Western Region along with TecAlliance organized a Webinar on Building Independent Aftermarket Open Catalogue for ACMA Members on 15th December 2020. The webinar was organised in view of major challenges faced by the growing Indian aftermarket segment. Which loses on the opportunity due to its highly unorganized nature.

ACMA has been actively working in this direction and has finalised on the Common Catalogue System through the services of TecAlliance. TecAlliance, an initiative of ACMA, is a consortium of Tec Doc from Europe and Pitzo, an Indian start up to provide the service.

The Aftermarket Catalogue will be a standard catalogue conforming to International TecDoc Cataloguing Standards, hosted in the cloud with full security and functionalities such as multiple search options, multiple view options, with the ability to integrate this with PoS (Point of Sales) systems.

The web catalogue will benefit the whole ecosystem around Aftermarket in the country which includes manufacturers,

distributors, retailers and the customers.

TecAlliance officials made a presentation on how the web catalogue is created and its benefits to the manufacturers, distributors, retailers and the customers.

The session was highly appreciated by all the esteemed participants.





#### 1st INTERACTIVE SESSION ON ACMA (WR) IT (DIGITAL) FORUM

ACMA, Western Region launched 'Digital Forum' and organized first interactive session on 1st December, 2020.

Mr. Rajeev Mittal, Chairman ACMA (WR) congratulated the Western Region for the initiative. While Mr. Piyush Tamboli, Chairman, ACMA (WR) said that the forum is very relevant and is the need of the hour, as it is created at a time when the industry is facing unprecedented disruption and digital technology has become the lifeline to survive. #### ONLINE TRAINING SESSION ON MSA

ACMA, Eastern Region, organised an online training session on Measurement System Analysis (MSA) for the benefit of its eastern region members on 28th November, 2020.

The objective of the program was to explain measurement concepts & fundamental analysis, analyze variation error in measurement results, Perform bias, linearity and stability studies.

Mr. Ranjan Vasishtha, with over 40 years of experience was the faculty for the training program. He is a bachelors in Mechanical Engineering from BITS Pilani (Rajasthan) and a Diploma in Management from IGNOU.

Welcoming the participants Mr. Anil Kumar Unni, Regional Secretary, ACMA (ER) mentioned that consistency & continuous enhancement in quality is key to customer delight and also helps in getting new business.

MSA is helpful for recording and determining repeatability and reproducibility for attribute and variables data. The training would help to methodically guide, conduct or evaluate bias, linearity, and



stability studies, he further added.

Mr. Vasishtha, during the session explained each step in detail and elucidated with examples on; what is measurement?, Objective and

its Purpose, Possible sources of process variation, MSA – REPEATABILITY, MSA – REPRODUCIBILITY, Accuracy Metrics, Fundamental of MSA, BIAS and linearity and MSA terms.

Mr. Unni, in his concluding remarks thanked the faculty and attendees for the wonderful session. A total of 22 delegates from 11

Companies participated in the session and the feedback received remained encouraging.

#### ONLINE TRAINING PROGRAM ON CYCLE TIME & COST REDUCTION USING VSM

ACMA, Eastern Region organised an online training session on Cycle time & Cost reduction using Variable Search Methodology (VSM) on 17th to 19th December, 2020.



Mr. Ramnarayan, a certified Six Sigma Master Black Belt holder was the faculty for the session. Mr. Ram had over a decade of experience working with leading industries and in the area of problem solving and coaching for over 2 decades.

In his welcome address Mr. Anil K Unni, Regional Secretary, ACMA

(ER) welcomed the participants. In his introduction, he emphasized on cycle time and cost reduction, which plays a vital role. Reduced cycle time means more output, which returns in greater opportunities and demand, he added.

The three day structured program included numerous case studies pertaining to the industry. During the session Mr. Ram, outlined the essence of the program, he mentioned that currently in many Organizations, process parameters designs are based on trial & error method, not on Systematic Design and Optimization procedures. As a result, there is always a huge scope to reduce cycle time and cost through redesigning Parameters.

He explained the following Key Points; Identification of Theme of Optimization, Listing down Design parameters, Identifying the Existing and + condition, Conducting trials to find out Significant and Non-significant Parameters, Finding out whether the contributions of Non-Significant Parameters are zero or not zero, Handling Non-Significant parameters and finding out the Optimal setting and Selection and fine tuning of Optimal setting.

A guiz was also organised to understand the level of understanding on a daily basis on the previous day's topics and participants were encouraged to ask questions. The training concluded with online assessment to gauge the understanding of the concepts.

The highly interactive and witnessed 12 participants from seven companies, it received positive feedback from the participants.



#### ONLINE TRAINING SESSION ON KIAZEN

ACMA, Eastern Region organised an online Kaizen training session on how to sustain the momentum on 28th December, 2020. The objective of the session was to ensure that the delegates understand the concept of Kaizen.

The target audience for the training were Supervisors, particularly for those who are involved in Quality, Team leaders & Middle Level Associates.

Faculty for the training was Mr. V. Thiagarajan, who has more than 35 years of experience and have worked for companies like HAL, Sundaram Clayton and Wabco.

He explained in detail how the improvements are based on small changes; In kaizen- what we are aiming is "Small-small incremental and steady improvements". Kaizen reduces waste – like inventory waste, time waste and unnecessary work or motion. Kaizen improves space utilization and product quality.

He further explained that for sustenance the following measures have to be there like;

- Proper SOP
- With instruction & Diagram
- Whatever is done should be robust & long lasting
- The steps should be followed properly
- The control plan should be updated
- Everything should be monitored & audited frequently
- After improvement, the changes should reflect
- Evaluation and tweaking the Kaizen as per the requirement is a

The session was appreciated by all the 10 delegates from 6 companies who attended the session.

Concluding the session Mr. Anil Kumar Unni, proposed the vote of thanks and took verbal feedback from all participants.

#### NORTHERN REGION

#### SECOND 5S COMPETITION, 2019-20

## SPECIAL INTERACTIVE SESSION WITH R C BHARGAVA

ACMA, Northern Region, organised an interactive session for the Interaction of ACMA Northern Region with Mr. R C Bhargava, Chairman, Maruti Suzuki India Ltd., on 29th January, 2021 over virtual platform.

Welcoming the esteemed Guest, ACMA President – Mr. Deepak Jain , thanked Mr. Bhargava for the continued support of MSIL during the lockdown period. He further highlighted the contribution of Mr. Bhargava and addressed him as the "Father of Indian Automobile Industry". Mr. Jain also welcomed Mr. Sunil Kakkar and Mr. Rahul Bharati of MSIL.

Addressing the participants, at the Special Interactive Session, ACMA NR Chairperson Ms. Shradha Suri Marwah, requested Mr. Bhargava, for his viewpoints on the Future of Mobility with respect to the current electric wave and government regulations.

Addressing the participants Mr. Bhargava, appreciated ACMA's role as a catalyst and the hard work to keep the growth momentum of the component industry. He expressed his concern over the slowdown of the economy due to the ongoing pandemic but also highlighted about the improved quarterly results of MSIL (compared to the lockdown period).

Mr. Bhargava started the session with the history of automobile industry spanning all the changes in the last four decades. He emphasized that the automobile industry played a big part in the economic recovery, as it had and has the potential to create jobs directly and indirectly. He informed the participants that India has a

huge market for car industry as it's in the growth stage and could certainly be a green pasture for International OEMs.

He further, highlighted that the present situation had to be carefully managed without hazarding the future. He stated that Government should support the industry by doing away with unwanted regulations, enabling the auto industry to manufacture cars at low cost and provide a level playing field for all manufacturers.

Mr. Bhargava, specially had a word of caution and advice for the emerging new generation in the Management of Auto Industry, and he notified that personal profits should be reduced for the bigger cause of Nation Development.

He further emphasized that the growth of the component industry should always be double the growth of the automobile industry as component industry is the backbone of the automotive industry.

He concluded his address by stating that for having a globally competent supply chain all the Tiers (I, II & III) should have the same Standards and Quality Guidelines.

The main session was followed by question & answer session and was moderated by ACMA Vice-President Mr. Sunjay Kapur.

The interaction concluded with a Vote of thanks by Ms. Anjali Singh - Co-Chairperson, ACMA NR.



ACMA, Southern Region, in collaboration with ACMA's Pillar 4 (Strategic Partnerships) organised the 2nd leadership lesson with Mrs. Anjali Singh, Executive Chairperson, Anand Group on "Power of Partnership and Succession Planning" on 9th November, 2020.

Ms. Shuba Kumar, Chairperson, ACMA (SR) & Managing Director, Natesan Synchrocones Pvt Ltd while proposing her welcome remarks, updated the participants on some of initiatives introduced by Southern Region including Help Kiosk, Best Practices Sharing, etc.

During the interaction Mrs. Singh, shared her views on how Joint Ventures are a tool for growth. She mentioned that by partnership they are able to deliver better & grasp the market & upgrade to the latest technologies.

While sharing their experiences Mrs. Singh mentioned that when looking for JVs it should always be for the long run and not for a short term. The JV partners should agree on & have a clear roadmap which avoids frictions. It is important to have a transparent & very strong corporate structure with strong team & where it is not for personal gain but to keep the institution healthy. She mentioned that it is important to maintain a good relationship with the companies even after dissolution of the partnership, as this gives a good perspective to the outside companies to have a JV with you in the future.

Concluding the session, she mentioned that the companies can look for technical licences to begin with, as that would be great way & approach and know the company prior to getting into a JV. This can be done with Korea & Japan in view of a strong presence of Korean & Japanese OEMs in India.

Summing up the session Dr. Lakshmi Venu, Co-Ordinator, Pillar 4-ACMA (SR) & Joint Managing director, Sundaram Clayton Ltd mentioned that it was an interesting session to know how such a large group like ANAND play as a bridge between their OEM customers catering to need of technologies with their partners and by adding value in a well-defined way.



To understand the level of understanding of the concepts, Mr. Ramanarayan, organised guiz contests on a daily basis on the previous day's topics to test the level of understanding by the participants and he also encouraged questions and clarified all doubts pertaining to particular topics covered.

And Consequences on non-compliance.

Mr. Gupta concluded his presentation with what was the suggested way forward for companies with 6 critical / focus areas that companies need to identify & concentrate on -

- Employee compensation structure
- 2. HR policies & processes
- 3. Payroll policies & processes
- 4. Third party contracts
- 5. Labour code compliance framework
- 6. Impact on P&L account

In Phase 1 of APOP the "Voice of the Customer" and "Market Research" are two important characteristics while taking inputs. These encompasses complaints, data and information, customer interviews, market tests and Product/ Process Benchmark data. This framework is a standardized set of quality requirements that enable

suppliers to design a product that satisfies the customer, he added. The topics that were covered in the training included:

- AIAG APOP Model
- Phases of APOP
  - 1. Plan and Define Program
  - Product Design and Development
  - 3. Process Design and Development
  - 4. Product and Process Validation
  - 5. Feedback, Assessment and Corrective action
- APOP Case studies.

Mr. Thiagarajan also presented various case studies where APQP was

ACMA, Southern Region, organised the 12th edition of ACMA Help Kiosk, on "Remission of Duties and Taxes on Exported Products (RoDTEP) Scheme" on 27th January, 2021.

Mr. Sriram Balakrishnan, Partner - Indirect tax/ GST practice, Ernst & Young LLP & Mr. Jayadev D, Manager, Ernst & Young LLP were invited as facilitators at this edition to deliberate on RoDTEP scheme which was implemented on 1st January, 2021.

Mr. Anil K Unni, Dy. Executive Director & Regional Secretary, ACMA (SR & ER) moderating the session mentioned that the session was organized to give members a clear understanding on the RoDTEP Scheme, with EY as Knowledge Partner.

Mr. Sriram mentioned that this scheme could have been implemented in the next financial year with more clarity on the scheme on eligibility, conditions & also the rate aspects, however, Govt. has decided to implement it from January, 2021.



Deliberating on the scheme the EY team mentioned of:

The WTO Challenge

In 2018, US Govt. raised a complaint against Indian Govt. as some of the schemes of Export promotion was not in consonances with the SCM agreement signed with WTO. Where after a year long deliberation WTO filed ruling against some of the Indian schemes on Export mainly MEIS. The panel reported a recommendation to withdraw the scheme within 120 days.

So, the Indian Govt. worked on implementing RoDTEP which would be more acceptable by WTO agreement. Where then on March 2020 the Govt. announced the approval of RoDTEP scheme & mentioned it would be implemented by January 2021.

During the session Mr. Sriram, deliberated upon various nuances of the Scheme and also mentioned the drawbacks. Some of the aspects which was discusses remained; What is RoDTEP Scheme?, Legal provisions involved under RoDTEP, Outline on RoDTEP Scheme, Taxes & Levies covered under ROSCTL, Overview on Data collection Exercise, RoDTEP Implementation, Ineligible schemes & its benefits, Features of RoDTEP scheme and Clarity from Government

He concluded the presentation advising the companies that once the RoDTEP rates are notified, the companies may evaluate the benefits notified under RoDTEP & under other duty exemption schemes (AAVEOU/Jobbing) so that the scheme offering the higher benefit may be availed.

The session was attended by more than 50 participants from Member & Non-Member Companies, participating virtually.

#### E-SESSION ON NEW LABOUR CODES


ACMA, YBLF, organized online session on E-Session on New Labour Codes on 28th January, 2021. The eminent speakers for the session was Mr. Rambir Dalal and Mr. S. K. Sharma.

Mr. Dalal is the Managing Partner of Peoplescient Consulting LLP a former Regional Provident Fund Commissioner and an ex-KPMG India Leader for Provident Fund, Pensions and Social Security Practice.

While, Mr. Sharma is an advocate with an expertise and experience in Labour Laws and Industrial Relations and a member of Central Board of Trustees (CBT), EPFO, Ministry of Labour and Employment, Government of India.



Session was moderated by Mr. Ishaan Gupta, Vice Chairman, Enco Engineers Combine Pvt. Ltd.



#### Key learnings of the session were:

- The Employer of any establishment shall register electronically under one single code.
- The code makes it mandatory for the organization appointing the workers to provide them all a letter of the appointment stating relevant details.
- · The code makes it mandatory for the employer to appoint welfare officer if 250 workers employed, earlier being 500.
- Worker is entitled to encash leave above ceiling as prescribed.
- As per the New Code, a Safety Officer is to be appointed on 500 workers in a factory, on 250 workers in hazardous process, on 250 workers in building or other construction and on 100 workers in a mine.
- Impact on Gratuity, PF, ESI, Maternity Benefit, Statutory Bonus, Retrenchment Compensation, Leave Encashment and other statutory payments.
- Impact Analysis of the New Codes.
- Review of existing HR Policies, Employment Contracts.
- Review of existing Contractor agreements and other Indirect employee engagements.
- Assistance in Implementation of necessary changes in Policies.
- Review of existing salary structure to analyze the various components of salary.
- Impact on Take Home Salary as per Indian tax law perspective & New Labour Codes.
